


### Instructions for Bid Submission for bidder

1. Bids are invited for purchasing and installation of LED Panel Display at B.P.Ed. Hall of Gochar Mahavidyalaya, Rampur Maniharan, Saharanpur.
2. Bids shall be submitted through registered post or by hand in person with in due date and time in three separate sealed envelopes i.e. General Information with EMD, Technical Bid and financial Bid.
3. Bids must be submitted in the prescribed format otherwise bids will be rejected.
4. Bidder must have good past record for supplying and installation of the work for the genuine/ government agencies.
5. Bidder must take acknowledgement certificate who submitted the bids in person in the office of the principal.
6. Bidder must have worked experience of the minimum three years and shall not be blacklisted ever by any government agency.
7. Bidder must have GSTN registered firm with good compliance record of the GST as per the rules and regulations of government of state as well as the center. If the bidder fails to comply this instruction, their bids shall be rejected.
8. Bidder shall submit EMD amount of **Rs Ten Thousand INR** only to the bank account of the Gochar Mahavidyalaya given in the tender document through demand draft/ by cheque / online mode within the date and time given in the tender document.

  - 5) Quoted rate shall remain valid for a period of **30 days** from the date of tender opening for the release of work order and will be firm throughout the contract period of **20 days** or till completion of work, once awarded and no cost escalation is allowed on any account.
  - 6) The item rate offered is for finished item of works and shall provide for the complete cost towards fuel, tools, tackles, plant & machinery, temporary works, labor, materials, levies, taxes, transport, lay-out, repairs, rectifications, maintenance till handing over, supervision, services, revenue expenses, overheads, profits & all other incidentals etc., complete. Rate quoted shall inclusive of GST.
- The Tenderer should be a GST Registered Contractor. If the proof of GST registration is not furnished the tender of the tenderer will not be eligible for opening price bid and become disqualified.**
- 7) Some changes are likely in the quantities furnished as well as in the supply, layout, design and specifications of the work. The rates quoted shall be deemed to be inclusive of all such contingencies
  - 8) The work shall be carried out as per drawings released then and there, specifications, and standard code of practice and as per the instructions of evaluation committee. The brief description of items of work is given in the bill of quantities.

- 11) The decision of evaluation committee shall be final and binding on the contractor regarding clarification of items in this tender schedule.
- 12) The works contract to be entered into with the successful tenderer will be governed by the rules and regulations made by evaluation committee.
- 13) The contractor shall strictly adhere to various labour laws in force.
- 14) To safeguard the persons working at height in roof, wall etc., enough Industrial Safety shall be provided at tenderer's cost in appropriate level and locations. 29) The Proprietorship / Partnership / Private Limited. / Public Limited contractor should submit the declaration form that we have not block listed from any Govt. depts./reputed private Ltd, companies or educational institution/universities during last 3years.

30) In the event of the disputes, differences, claims and questions arising between the parties hereto arising out of this agreement or anyway relating here to or any term, condition or provisions herein mentioned or the validity, interpretation, thereof or otherwise in relation hereto, all such dispute claims or question shall be referred to Sole Arbitrator appointed by the Gochar Mahavidyalaya. Bid security cost shall be 2% of the total cost of the project which is decided by the technical evaluation committee for the large enterprises.

As per rule 170 of General Financial Rules (GFRs) 2017, Micro and small Enterprises (MSEs) and the firms registered with concerned Ministries/Departments are exempted from submission of Bid Security. 35) The tenderers are advised to go through the condition stipulated in Tender document & code of conduct for Safety of Contract Laborers in details. Any violation thereof will invite punitive action being taken against them. While quoting the rate all the above factors are to be considered.

36) **Compensation for Delay:**

If the contractor fails to maintain the required progress or to complete the work and clear the site on or before the contracted or extended period of completion, he shall, without prejudice to any other right or remedy of the Gochar Mahavidyalaya on account of such breach, pay as agreed compensation an amount calculated as stipulated below. This will also apply to items or group of items for which separate period of completion has been specified.

For this purpose, the term 'Contract Value' shall be the value at contract rates of the work as ordered and the compensation for delay is by way of recovery at 1 percent of contract value per week of delay provided always that the total amount of compensation for delay to be paid under this condition shall not exceed 10% of the contract value or of the contract value of the item or group of items of work for



which a separate period of completion is given.

The amount of compensation may be adjusted or set-off against any sum payable to the Contractor under this or any other contract with the Gochar Mahavidyalaya.

**37) Arbitration:**

Except where otherwise provided for in the contract all questions and disputes relating to the meaning of the specifications, designs, drawings and instructions hereinbefore mentioned and as to the quality of workmanship or materials used on the work or as to any other question, claim, right, matter or thing whatsoever in any way arising out of or relating to the contract, designs, drawings, specifications, estimates, instructions, orders or these conditions or otherwise concerning the work or failure to execute the same whether arising during the progress of the work or after the completion or abandonment thereof shall be referred to the sole arbitration of the Principal of Gochar Mahavidyalaya and if Principal is unable or unwilling to act, to the sole arbitration of some other person appointed by the Principal, willing to act as such arbitrator. The cases referred to arbitration shall be other than those for which the decision of the Principal is expressed in the contract to be final and conclusive. There will be no objection if the arbitrator so appointed is an employee of Gochar Mahavidyalaya and that he had to deal with the matters to which the contract relates and that in the course of his duties as such he had expressed views on all or any of the matters in dispute or difference.

The arbitrator to whom the matter is originally referred being transferred or vacating his office or being unable to act for any reason, Principal as aforesaid at the time of such transfer, vacation of office or inability to act, shall appoint another person to act as arbitrator in accordance with the terms of the contract. Such person shall be entitled to proceed with the reference from the stage at which it was left by his predecessor. Subject as aforesaid the provision of the Arbitration & Reconciliation Act, 1996 or any statutory modification or re-enactment thereof and the rules made there under and for the time being in force shall apply to the arbitration proceeding under this clause.

**PAYMENT OF BILLS: -**

All payments to be made to the Contractor, under this contract shall be by NEFT or RTGS or by Cheque as per the decision of the purchase committee formed by principal, after the certification of bills by the execution department.

**RECOVERY FROM CONTRACTOR: -**

Whenever under the contract, any sum of money, shall be recoverable from or payable by the supplier, the same may be deducted from or any sum then due or which at any time thereafter may become due to supplier under the contract or under any other contract with Gochar Mahavidyalaya he shall pay the claim on demand.

**SPECIAL POWER TO TERMINATION: -**

If at any time after the award of contract, Gochar Mahavidyalaya shall for any reason whatsoever not require whole or any part of the work to be carried out the Evaluator in charge shall give notice in writing of the fact to the supplier/ contractor who shall have no claim to any payment of compensation or otherwise howsoever on account of any profit or advantage which he might have derived from the execution of the work in full but which he did not derive in consequence of the fore-closing of the work.

**LABOUR: -**

The supplier shall remain liable for the payment of all wages or other moneys to his work-people or employees under the payment of Wages Act 1936, Employees Liability Act. 1938, Workmen's Compensation Act 1923 or any other Act or enactment, relating thereto and rules framed, there under from time to time.


